A Program Environmental Impact Report (EIR) was prepared by the Council of Fresno County Governments (COFCG or Fresno COG) for the proposed COFCG 2007 Regional Transportation Plan (RTP). The EIR discusses the potential impacts of transportation improvements associated with the RTP in the Fresno County region consistent with anticipated population growth to the year 2030.

On May 31, 2007, the Fresno COG Policy Board, the Lead Agency, adopted Resolution No. 2007-15 certifying the Final EIR and made the determinations/findings required by the California Environmental Quality Act (CEQA). Specifically, the Fresno COG Policy Board made the determinations listed below:
