



## **SOCIAL SERVICES TRANSIT ADVISORY COUNCIL (SSTAC) Application Package**

The Fresno COG Policy Board established its Social Services Transportation Advisory Council (SSTAC) in 1998 to review transit issues with emphasis on annually identifying transit needs within Fresno County. Transit needs include those of transit-dependent and transit-disadvantaged persons, including the elderly, disabled and persons of limited means. This advisory Council is consistent with State law (SB 498, Chapter 673, 1987), which mandates both the purpose and membership of this body. All SSTAC meetings are open to the public. Citizens can request to be placed on the mailing list to receive council agendas. SSTAC meets the third Tuesday of the month, January through June or as needed.

Fresno COG seeks representation from the members of the community that the Council services from urban and rural areas within Fresno County. The communities that the SSTAC represents includes:

- transit-dependent and transit-disadvantaged persons, including the elderly, disabled and persons of limited means. Specific groups include:
  - Potential Transit User 60 Years of Age or Older
  - Representatives of the Local Social Service Providers for Seniors
  - Potential Transit User Who Is Disabled
  - Representative of the Local Social Service Provider for Disabled
  - Representative of a Local Social Service Provider for Persons of Limited Means
  - Representatives from the Local Consolidated Transportation Service Agency
  - Representatives of General Public, who used Public Transit

Members serve 2-year terms, with no maximum limit of representation on the Council.

Urban areas include members of the community from the Fresno Clovis metropolitan statistical area.

Rural areas include those communities within Fresno County outside of the Fresno Clovis metropolitan statistical area.
