

Dear interested Senior for the “Measure C Senior Scrip” program,

Thank you for expressing your interest in signing up for the “Measure C Senior Scrip” program! The “Senior Scrip” program provides discounted vouchers/credits to pay for: taxi fares with participating taxi providers, Lyft-Uber rides dispatched through GoGoGrandparent, and transportation with eligible Non-Emergency Medical Transportation providers.

To become a “Senior Scrip” user that can purchase the discounted vouchers/credits, also known as “Scrip,” you must first complete the “Measure C Senior Scrip” application provided to you. This application asks for information, such as your: name, current residing address, date of birth, signature, etc. Please fill out the application to the best of your abilities, provide a copy of your “Proof of Age and Residency,” and submit it through one of the following ways:

Here is a checklist for your “Senior Scrip” application that list what must be completed before submitting your application.

MEASURE C SENIOR SCRIP APPLICATION CHECKLIST

- **Completed Application** – Your application must have: name, address, city, state, zipcode, phone number, date of birth, applicant signature, and the date signed completed. Providing an email address is encouraged since it is the quickest way for staff to reach out to the applicant, but not necessary.
 - If your application does not include the following information, it will be returned to you and a letter stating why the application was returned due to an incomplete application. You will then have to resubmit your application after providing missing information.
- **Copy of Proof of Age and Residency** – Your copy of “Proof of Age and Residency” must match the date of birth and address listed on the application form. Examples that list both age and residency are “Driver’s License” or “Senior ID Card.” You can also provide a combination of documents issued by the city, county, state, or federal government to prove your age and residency. These documents must have your name addressed in the form/document.
 - If the Proof of Age and Residency does not match the application, your application will returned to you and a letter stating that your application and “Proof of Age and Residency” do not match. You will then have to provide a different copy of “Proof of Age and Residency” that does matches the application’s date of birth and residency.

APPLICATION FOR THE “MEASURE C SENIOR SCRIP” PROGRAM

The Measure C Senior Scrip Program began in 2008 to provide transportation for seniors living in Fresno County. The “Senior Scrip” program is operated by Fresno Council of Governments (Fresno COG) and funded with local transportation funds made available through the extension of Measure C. Eligible Fresno County residents may use approved taxi service, Non-Emergency Medical Transportation (NEMT) providers, and Lyft/Uber through GoGoGrandparent to travel anywhere their service is available with prepurchased “Scrip.” “Scrip” comes in two variations: “Paper Scrip” which are paper vouchers used to pay for Taxi and Non-Emergency Medical Transport (NEMT) fares with eligible providers or “E-Scrip” which are digital credits used to pay for Lyft-Uber fares scheduled and dispatched through GoGoGrandparent.

To be eligible for the program, the applicant must be 70 years of age or older and a resident of Fresno County. **When applying, seniors are required to provide proof of age and residency, such as a copy of a California driver’s license, California Identification Card or other combination of documents that prove both age and residency.** Submitted “Proof of Age and Residency” must match the information listed on the application. If the information does not match, the application will be returned to the applicant.

You can submit the application and proof of age and residency through one of the methods listed below or at one of our “Vendor” locations listed on page 4 of the Frequently Asked Questions. For more information, please call Fresno COG at 559-233-4148 or visit us on the web at www.fresnocog.org.

"Frequently Asked Questions and Answers" about the Measure C Senior Scrip program

What is the "Measure C Senior Scrip" program?

"Senior Scrip" is a Measure C funded program that provides alternative, reliable, and affordable transportation to Fresno County residents 70 years of age and older. Eligible seniors receive a 75% discount on vouchers or credits to pay for transportation fares by purchasing and using "Scrip." "Scrip" is sold as either "Paper Scrip" to pay for taxi fares with approved Taxi or Non-Emergency Medical Transportation providers and "Electronic Scrip" or "E-Scrip" for Lyft-Uber rides scheduled through GoGoGrandparent.

How does the Senior Scrip Program work?

Each month, seniors will have a choice to purchase "Paper scrip" which are paper vouchers that can be used to pay for transportation fares with approved taxi or Non-Emergency Medical Transportation providers or "Electronic scrip (E-Scrip)" which are digital credits that can be used to pay for Lyft/Uber rides scheduled through GoGoGrandparent. Eligible seniors can purchase "Scrip" in increments of \$5.00 for the value of 20 Scrips and can purchase up to the maximum amount of \$50.00 for the value of 200 Scrips. Each Scrip is equivalent to \$1.00, but through the "Measure C Senior Scrip" program, you only pay \$0.25 per Scrip. This is a 75% discount!

Paper Scrip *for Taxis*

What is Paper Scrip?

Paper Scrip is a voucher accepted by approved Taxi providers. Paper Scrip is sold in "booklets" of 20 individual scrips bundled together. Users pay only a quarter of the Paper Scrip value, so each "booklet" costs users \$5.00. Scrips can be used like cash to pay for taxi service fares and tips only.

Where do I buy paper scrip and how much can I buy?

Paper Scrip can be purchased: online at seniorscrip.org, over the phone with Fresno COG, mail-in order, or in-person at one of the various "Vendor" locations throughout Fresno County. Seniors can purchase up to 200 Scrips (Paper or Electronic) for the cost of \$50.00. The purchasable amount of Scrip resets the first day of each month.

How do I schedule a taxi ride?

To schedule a ride, call one of the approved taxi providers from the list and let them know you are paying for the fare with Paper Scrip. Senior Scrip users are responsible for scheduling, changing, and cancelling your own trip reservations. Not all Taxi companies operating in Fresno County accept Paper Scrip as a form of payment.

When are taxi rides available?

Taxi cabs are available most hours and days of the week. Users should call one of the approved Taxi providers before their appointment and ask if they operate at your needed appointment date and time. Senior Scrip does not control when the Taxi providers' business operation hours.

Paper Scrip for Taxis

Does my paper scrip expire?

No. All purchased scrip does not expire. Scrip does not need to be used in the same month it is purchased. All purchased Scrip (Paper or Electronic) can be used at your convenience.

Can someone else ride with me?

Yes. Other people may accompany you at no extra charge, as long as the passenger limit does not exceed 4 passengers.

How long will I have to wait for my ride?

Your waiting time for your taxi provider should not be more than 20 minutes. If a taxi provider is later than 20 minutes, they are required to let you know so you can choose to continue waiting for them or call another taxi service provider.

Can I schedule a taxi ride in advance?

Yes. Some Taxi providers can accept a scheduled taxi ride in advance. However, most prefer that you call the day you need the ride, even if you schedule it with them in advance.

How do I pay the taxi driver?

To pay your fare, you can pay your entire fare with Paper Scrip. If you do not have enough Paper scrip, drivers will ask for the remaining balance to be paid with credit/debit card or cash.

How will I know how much to pay?

Taxi cabs have a meter that displays the trip fare and dispatchers can estimate the trip fare over the phone.

May I tip the driver with paper scrip?

Yes. You can tip with Paper scrip or cash if you feel the service provided is exceptional.

Can I give or sell my paper scrip to someone else if I do not use it?

No. Senior Scrip can only be used by the purchasing and assigned user, it cannot be passed onto another senior. **Senior Scrip is non-negotiable, non-transferable, non-replaceable or refundable.**

I am a Fresno County resident, but I want to travel to out of county, can I use paper scrip for this trip?

Yes. However, the amount of paper scrip you are allowed to purchase may only cover part of the total cost of your trip. Ask the taxi company for an estimate of the fare before scheduling a service. Approved taxi providers may not be able to pick you up outside of their service area, call them and ask before scheduling.

How do I SIGN UP for the Senior Scrip Program?

To sign up, you must complete and submit the "Application for Scrip" along with your proof of age and residency through one of the approved methods to become an eligible Senior Scrip user and be able to purchase scrip.

Paper Scrip

for Non-Emergency Medical Transportation (NEMTs)

What is a "Non-Emergency Medical Transportation (NEMT)?"

"Nonemergency medical transportation (NEMT) is transportation by ambulance, wheelchair van, or litter van for those who cannot use public or private transportation" as defined by the Department of Healthcare Services (DHCS.) Senior Scrip users can schedule a ride with an approved NEMT to go anywhere you need to and you can use your Paper Scrip to pay for those fares!

Who should use the NEMTs?

Any and all Senior Scrip users can schedule a ride with one of the approved Non-Emergency Medical Transportation (NEMT.) The service benefits users who physically cannot take taxis or other non-wheelchair accessible vehicles due to physical limitations. Users that benefit the most from using NEMTs include, but are not limited to: individuals who cannot get in and out of vehicles without assistance, powered wheelchair or scooter users, or individuals with sensitive medical equipment.

When and where can I use an NEMT?

NEMTs can be used 24 hours a day, 7 days a week. But call the approved NEMTs at least 48 hours before your appointment to make sure they are driving when you need them.

How do I pay my fare with an NEMT?

Paper Scrip can be used to pay for your fare with the approved NEMTs. When scheduling your appointment, tell the Operator that you are paying with Paper Scrip. When you are picked up for your ride with the NEMT, you will pay the fare with your Paper Scrip before they bring you to your appointment. If you do not have enough Paper Scrip for the transport, you are responsible for paying the remaining amount of the fare with a credit/debit card, check/money order, or cash.

How much does it cost to ride with the NEMT?

NEMTs will give you an estimate of the fare when scheduling your ride and NEMT fares can be more expensive than taxi fares. NEMT fares are more expensive because they offer specialized vehicles that can transport anyone, drivers receive specialized training to give you and all riders the most comfortable ride, and you can schedule your rides in advance.

How do I schedule a ride with an NEMT?

To schedule a ride with an NEMT, call one of the approved providers at least 48 hours before your appointment. During your call with the NEMT, you will tell the operator: where you need to go, when you need to be picked up, the type of vehicle you need, and your contact information if they need to call or text you.

Electronic Scrip

for Lyft-Uber through GoGoGrandparent

What is electronic scrip credit?

Electronic Scrip, also known as "E-Scrip," are digital credits used to pay for Lyft-Uber rides scheduled through GoGoGrandparent. Electronic Scrip is sold in increments of 20 scrips for the cost of \$5.00, up to the maximum amount of 200 scrips for the cost of \$50.00.

Where do I buy electronic scrip and how much can I buy?

E-scrip can only be purchased through Fresno COG: online, over the phone, mail-in order, or in-person. E-Scrip is not sold at any other

Vendor locations or through GoGoGrandparent. Seniors can purchase up to 200 Scrips (Paper or Electronic) for the cost of \$50.00. The purchasable amount resets the first day of each month.

How do I schedule a Lyft/Uber ride?

To schedule a Lyft-Uber, call GoGoGrandparent to schedule and dispatch a Lyft-Uber at

855-464-6872. GoGoGrandparent schedule and dispatch Lyft-Uber rides, so you do not need to own or use a smartphone or download an app to book a ride.

When are Lyft/Uber rides available?

Lyft-Uber rides are available to schedule through GoGoGrandparent operators 24 hours a day, 7 days a week. Availability of drivers can be limited based on time and date of ride requested.

Does my electronic scrip credit expire?

No. All purchased scrip does not expire. Scrip does not need to be used in the same month it is purchased. All purchased Scrip (Paper or Electronic) can be used at your convenience and when needed. Any remaining balance at the end of the month will roll over for you to use in the following month(s) as needed.

Can someone else ride with me?

Yes. Other people may accompany you, at no extra charge, as long as the passenger limit does not exceed 4 passengers.

How long will I have to wait for my ride?

Driver availability depends on location, the time of day, and other factors at the time of your ride being requested. In most cases, your ride will arrive within 5-15 minutes after confirming your ride with the GoGoGrandparent operator, so, be ready to leave after confirming your ride.

Can I schedule a Lyft/Uber ride in advance?

Yes, you can schedule your Lyft-Ubers up to two (2) weeks or one (1) hour with GoGoGrandparent. If your plans change and you need to reschedule or cancel your ride, call GoGoGrandparent as soon as possible or else you are subject to a "cancellation fee."

How do I pay the Lyft/Uber driver?

Lyft-Uber drivers are paid directly from your "E-Scrip" balance from your GoGoGrandparent account. Do not give the driver a credit/debit card or cash at the end of the fare.

How will I know how much to pay?

GoGoGrandparent will provide an estimate of your fare when you call to schedule your ride. After your ride has been completed, GoGoGrandparent will email your receipt that states the exact amount of your fare that was charged to your "E-Scrip" balance. You can also call the Operators to ask how much you were charged for the ride.

Can I tip the driver with E-Scrip?

Yes, you can tip the driver with your "E-Scrip." To tip the driver, call GoGoGrandparent before the ride is complete and tell them the amount you would like to tip the driver.

Do all Lyft or Uber drivers help you with your groceries or into the car?

No, not all do. When scheduling your ride with the GoGoGrandparent operator, tell the Operator that you need extra help so they can match you with a driver that is physically capable to help you with your groceries or into the car.

Electronic Scrip

for Lyft-Uber through GoGoGrandparent

Can I give or sell my electronic scrip to someone else if I do not use it?

No. Your Senior Scrip electronic ride credits can only be used by you and should not be used to schedule Lyft-Uber rides for others. **Senior Scrip is non-negotiable, non-transferable, non-replaceable or refundable.**

I am a Fresno County resident, but I want to travel to Merced, can I use electronic scrip for this trip?

Yes. GoGoGrandparent is available wherever there is Lyft-Uber service. However, the amount of electronic scrip you are allowed to purchase may only cover part of the total cost of your trip. Before scheduling a service, ask the GoGoGrandparent operator to ensure you have enough electronic scrips needed for your trip.

I am a resident of Kings County; can I participate in the Senior Scrip Program (with electronic scrip)?

No. Measure C's Senior Scrip Program is available only to Fresno County residents. Contact your respective city or county offices for senior programs available in your area.

How do I SIGN UP for the program that allows me to order Lyft/Uber rides?

All seniors already enrolled in the Measure C Senior Scrip Program must complete and submit the **"Application Addendum"** to Fresno COG. Seniors not yet enrolled as Measure C Senior Program users must complete and submit both applications at the same time to be eligible.

Cancellation Fees from Lyft/Uber rides:

"Cancellation Fee(s)" are charged to users who do not cancel their fare dispatched through GoGoGrandparent within 3-5 minutes of the driver confirming they will pick you up. If you need to cancel your ride with Lyft-Uber through GoGoGrandparent, call them immediately or else you will be charged a "Cancellation fee." The average "cancellation fee" cost is between \$5.00 and \$10.00. The cancellation fee amount is determined by Lyft-Uber, GoGoGrandparent and Senior Scrip have no control on the amount charged.

No-Show Fees from Lyft/Uber rides

"No-Show Fee(s)" are charged on rides where users did not show up or arrive to the Lyft-Uber driver within 5-7 minutes of the driver arriving at the pickup destination. Users are advised to be ready when the driver has confirmed they will pick you up from the destination to avoid being charged a "No-Show Fee". GoGoGrandparent and Senior Scrip have no control on the amount charged.

Finding out your Electronic Credit balance with GoGoGrandparent

To find out your current balance of "E-Scrip," contact GoGoGrandparent at (855) 464-6872. GoGoGrandparent can also send you your current "E-Scrip" balance through email or text by talking to an operator.
