## Dr. Ken Bird, MD, MPH, Deputy Health Officer/TB Controller Fresno County Department of Public Health

Dr. Bird will brief us on the status of health in Fresno County, particularly with regard to those chronic illnesses associated with lack of physical activity and to a lesser extent air quality.

Ken Bird trained initially as a pediatrician and has been in general medical practice for 34 years. He practiced aerospace medicine in the U.S. Navy for five years and has been a public health physician with the Fresno County Department of Public Health since 1986. Ken was medical director of the Fresno County Department of Public Health's Jail Medical Services for fourteen years, and served as interim Health Officer for Fresno County from January to August of 2003. He has been tuberculosis controller, communicable disease controller, and deputy health officer since May 2005. He is active in the California Tuberculosis Controllers Association (CTCA) and is a past president. Ken received his Master of Public Health degree from the University of Massachusetts at Amherst in 2008. He has been Interim Health Officer for FCDPH since January 6th of this year.

SCAG is the metropolitan planning organization for the LA Metro region which includes 6 counties and 38,000 square miles. SCAG is tasked, among other things, with developing long range transportation plans for

the region. As part of this effort, Alan develops regional goals, strategies and policies for active transportation and transportation safety programs.

In 2012 SCAG adopted the Active Transportation Plan for Southern California which, once implemented will increase the existing bikeway network from 4,000 miles to over 10,000 miles and develop a regional bikeway network modeled after the U.S. Bicycle Route System.

Alan Thompson brings over 17 years planning experience in all modes of transportation, from airport planning to active transportation. Past efforts include development of the Aviation System Plans, assisting in the Southern California Regional Aviation System Plan, the Southern California Catastrophic Earthquake Preparedness Plan, updating the Regional Intelligent Transportation Systems Architecture, and developing the Active Transportation Plan for Southern California and the Congestion Management Plan for the Los Angeles Metro Region. Alan earned a Bachelor of Science degree in aviation management from Southern Illinois University. He holds a Master of Arts in Public Administration, also from SIU. Craig has worked at the Metropolitan Transportation Commission for over 20 years both on the planning and funding sides of the agency. He currently develops and manages federally funded programs, including new innovative funding approaches. They include the country's first Safe Routes to School Program funded by a Metropolitan Planning Organization, the Priority Conservation Area Program, and the OneBayArea Grant Program, which incentivizes transportation funding decisions based on local

Marco Anderson, Senior Regional Planner & Deputy Lead for the Sustainability Planning Grant Program, Southern California Association of Governments (SCAG) "Sustainability Planning Grant Program"

Marco Anderson is a senior regional planner with the Southern California Association of Governments (SCAG) and was appointed coordinator of the Southern California Clean Cities Coalition in May, 2014. He currently works in the Sustainability Department focusing on integrating land use and transportation policy. Anderson is the project manager for the SCAG Electric Vehicle Readiness Program and is the deputy lead for the Sustainability Planning Grant Program which provides funding for local land use plans and studies. These efforts foster and implement the Sustainable Communities Strategy (SCS) principles of mobility, livability, prosperity, and sustainability. Mr. Anderson was also the SCAG project manager on a two year Caltrans Planning Grant led by UCLA, studying the impact of high speed rail stations on local communities.

Before working at SCAG, Anderson was a transportation planner at a multi-disciplinary planning-engineering-architecture firm in Orange County and worked on a variety of transportation plans ranging from local access transit plans and traffic impact studies, to major sub-regional corridor plans.

Coleen Clementson has more than 20 years of experience in public sector land use and transportation planning in the San Diego region.
